5. Conducted a literature survey to identify a research question to analyze using LC/MS/MS instrument.

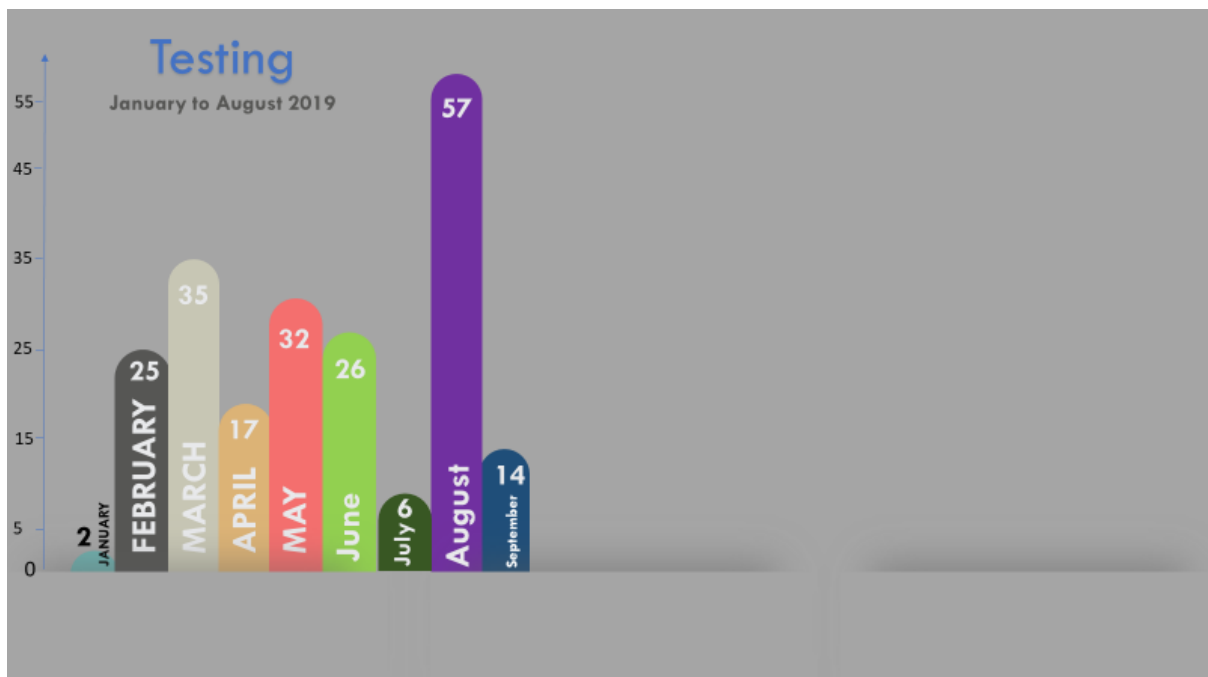

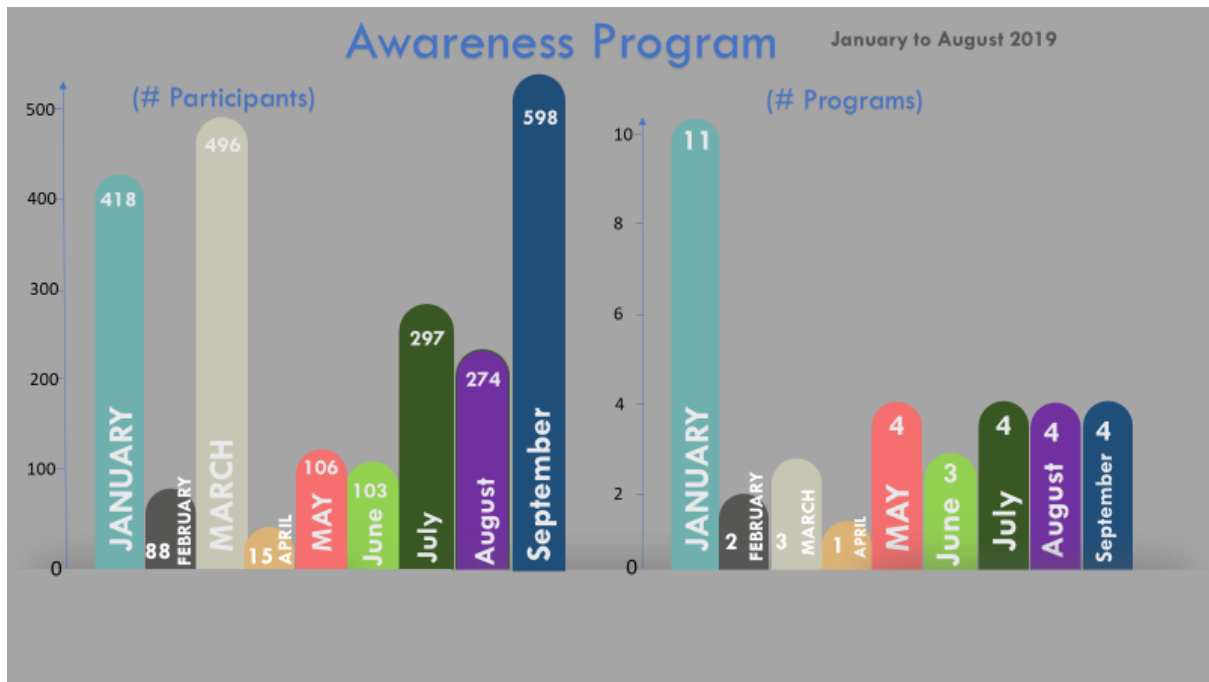
